We developed Infinity to address the needs of horses who have allergies to soybean meal, hay, flax and more.

The base of Infinity is sugar-free Beet Pulp pellets that have been slightly ground. To this we add *peas* and *sunflower seeds* for a for great coat, and pressed Canola Oil for a 2:1 Omega 6 to 3 ratio.

Infinity is manufactured at a non-GMO mill in Lebanon, PA and isolated from medicated feed lines.

Feed at a rate of 3 to 5 lbs. per 1100 pounds of body weight per day for a horse in moderate working conditions. Always provide fresh water and forage. 2040 kcal/lb.
